

BACKGROUND

The history of the production and distribution of electricity in our region makes for a long and twisting tale. It begins with our area's first electric plant built by James F. Crumley in 1888. By 1891, Crumley's plant had become the Watauga Lighting & Power Company and remained as such until its purchase by the Johnson City - Jonesborough Electric Light and Power Company in 1902. As the population and its demand for electricity continued to rise throughout Washington County, the need for further expansion and production became increasingly evident. Consequently, a hydroelectric plant was built on the Nolichucky River near Greenville in 1911. Transmission lines were then constructed connecting the new plant to the various power companies serving Greenville, Jonesborough and Johnson City, thus creating the Tennessee Eastern Electric Company. This company enjoyed many years of operation and expansion, during which, a new steam plant was constructed in Watauga and the height of the original dam on the Nolichucky River was raised to offset the area's ever growing demand for electricity.

The need to manage the distribution of greater loads of electricity throughout upper East Tennessee brought about the formation of a new corporation in 1929. This corporation, The East Tennessee Light and Power Company, eventually grew to serve an area of more than four thousand square miles within nine counties while connecting more than one hundred thousand customers to locally generated electricity. This company continued its operations until Tennessee Valley Authority purchased it in 1945, establishing them as the sole distributor of electricity in our region. By resolution of the City of Johnson City on June 18, 1945, at 7:00 pm, city officials executed and delivered to the TVA a contract captioned, "Sales Agreement," for the purchase of an electric distribution system serving portions of Washington, Sullivan, Greene and Carter Counties at a base price estimated at \$2,002,500.00. The company charged with maintaining this system was then named the Johnson City Power Board.

During its first year of operation the Johnson City Power Board served a total of 9,778 customers and purchased a total of \$219,139.99 worth of electricity from the TVA. Our most recent financial figures show that the JCPB purchased \$118,656,751.00 worth of electricity from the TVA in order to serve its 72,966 metered customers.

Our mission as a power distributor is to be recognized by our customers, non-customers, and competitors as the leading energy and energy services provider in the region. We will: Seek out, understand, and act upon our customers' needs; Provide the highest quality energy and services at the lowest possible rates; Conduct all business with integrity and honesty; Promote and support economic development programs for the benefit of all.
